4. Black listed firms will not apply.

6. Warranty for the equipment, as approved by manufacture/supplier but not less than one years.
7. In case any supply/material/is found not in conformity with the specifications provided in the tender, earlier on account of inferior quality, defective workshop, faulty design ,faulty packing, short supplied or wrongly supplied , the supplier shall replace the same free of charge.
